1. Website Visitors

Like most website operators, Sensorium Corporation collects non-personally-identifying information of the sort that web browsers and servers typically make available, such as the browser type, language preference, referring site, and the date and time of each visitor request. 4. Sensorium Corporation uses Google AdWords for remarketing

Sensorium Corporation uses the remarketing services to advertise on third party websites (including Google) to previous visitors to our site.
